


FIGURE 1 / GRAPHIC 25-23-09-991-001




FIGURE 2 / GRAPHIC 25-23-09-991-002



CLEANING

Remove surface dust with soft cloth. Shake bottle contents and apply a light mist. Spread evenly and buff with a clean, soft, lint-free cloth.

Shake contents firmly and apply evenly to any hard, shiny, non-absorbent surface at room temperature. Rub gently. Before surface dries, polish with a dry lint-free cloth or non-damaging material, until the surface feels "as smooth as ice".

C. Shade fabric

Lou Martin easy-glide shade systems utilize a metallized fabric, which is inherently anti-static. They actually repel dust and seldom require cleaning. An occasional light sweep of a vacuum is all that should be needed.

In the event of a mishap, Lou Martin easy-glide shades may be cleaned with a mild detergent and water. However, water spotting can occur. If a detergent is required, we suggest a mild detergent such as woolite.

Do not use ammonia cleaners near the Lou Martin easy-glide shade. Ammonia cleaners will damage the shade.

AIRWORTHINESS LIMITATIONS

TASK 25-23-09-200-801

- 1. <u>General</u>
 - A. The Airworthiness Limitations section is FAA-approved and specifies maintenance required under §§43.16 and 91.403 of the Federal aviation regulations, unless an alternative program has been FAA approved.

Inspections are to be carried out at the discression of Lufthansa Technik and owner of the aircraft.

Write all the damage detected, in some condition, the cause and/or the source. Immediately repair all the damage found.

- B. Visually check all hardware, detail parts and assemblies for the following criteria:
 - (1) Wear, tears, fraying of the shade & decorative mask fabric.
 - (2) Tightening of the screws and nuts
 - (3) Condition of the Protective Lenses for scratches, cracks or spots.
 - (4) Condition of the alum frame and wood frame molding for scratches, chipping or fading of the paint.
- C. Do a careful check of all the parts for corrosion, distortion, incipient cracks, cracks, dents, nicks, scores, stripped threads, excessive wear, etc. which can damage the performance of the equipment and give it an unsatisfactory condition.

<u>NOTE</u>: Assure window unit lenses, plated parts, decorative mask parts are protected at all times when work is being done.

3. <u>Replacement procedure for a damaged protective lens</u>

- A. Mark both sides of protective lens on frame to assure replacement protective lens is properly located during reassembly.
- B. Remove protective lens from window assy. (See "DISASSEMBLY", section 5)
- C. Trim replacement inner lens to size, ref chart on previous page for lens material specs. Lens size is the same for both sides of window unit. Lens size is 60.06 X 37.09.
- D. Before attaching new lens decide which side of lens is to be attached to reveal. Remove this side's protective film. Note: use a static blow-off gun to eliminate dust attraction.
- E Remove screws holding decorative mask in place. Assure that both mask and lens are aligned correctly with frame prior to attachment.
- F. Clamp replacement protective lens to window assy., assure lens follows the curve on contour spacer. Note: it will help if the either left or right of lens is clamped first then the other side, this will force the lens to follow contour's curve. Test shade up & down to check for tension. Loose lens will ease the tension on the shade, if not refer to "Testing & Fault Isolation"
- G. Attach new protective lens to window frame assy. Match drill lens with existing attachment locations. Note: when drilling assure not to damage nut plates located on backside of reveal. Then remove clamps. (See "ASSEMBLY", section 4)

- 4. <u>Replacement procedure for any blind mod component</u>
 - A. Due to the complexity and precision required for optimal shade operation, Lou Martin & Associates, Inc. recommends returning the window unit to the factory to ensure optimal operation.

- A. After removing window unit from bulkhead, uninstall back-up battery control unit from bulkhead. Reference Lufthansa Technik completion center specifications for removal procedure.
- B. Remove four screws holding top panel in place, and remove both 12V batteries. This is also a good time to check batteries for any leakage or corrosion of connection contacts.
- C. If battery does not recharge to a desirable level or shows major wear (leakage, corrosion on contacts, etc...), Lou Martin & Associates, Inc. recommends replacement of battery to maintain optimal operation.
- D. When recharge/replacement is completed re-insert both batteries in back-up control unit and re-attach top panel with four screws.
- E. Re-insert battery unit in bulkhead per Lufthansa Technik completion center specifications


